The benefits of the E-Z Flo® pressure demand regulator start with first breath activation. It is highly responsive to the user's breathing requirements and will provide peak flows of up to 500 standard liters of air per minute. Its low exhalation resistance means less effort to breathe and less fatigue. The regulator assembly is available with a variety of fittings: Hansen, Schrader, Foster or Hansen HK.

Doffing is made simple with the E-Z Flo's air-saver switch. Depressing the air-saver switch immediately stops the air flow into the mask.

The E-Z Flo Regulator with Modulair™ option enables easy connect/disconnect from the respirator for cleaning personal issue, or replacement. With Modulair, the regulator can easily be replaced without taking the respirator out of service.

Harness

The nylon harness includes a shoulder strap for comfort and a quick release metal buckle. A strain relief mechanism located on the waist belt prevents the regulator's air hose from tugging on the regulator.

Facepieces

The E-Z Airline is approved with Scott's AV-2000, AV-3000, AV-3000 SureSeal System, AV-3000 HT, Scott Sight and Weld-O-Vista full facepieces. See chart below for common part numbers.

Each facepiece features a hardcoated polycarbonate lens and wide field of view. To suit multiple needs facepieces are available with Polyester, or Kevlar®, and a rubber harness.

Hoses

Hoses are approved as part of the respirator, so use of approved hoses is required. 3M Scott offers a wide range of fittings and hose lengths to meet your needs. Hoses range from 6 feet to 300 feet, or can be coupled together for a maximum length of 300 feet. See chart below for common parts numbers and user instructions for more details.
